Terms and Conditions**

Payment Policies

All payments can be made payable to Wild Roots Preschool and Child Care Center by check or money order. Monthly payment tuition is due at on the first of the month, no later than the 5th of each month. **A late fee of \$25 will be added to your monthly tuition if it is not received by the 5th of every month.** If tuition is not received by the 10th of the month, care will not be provided until tuition has been paid in full, including all late fees. A fee of \$35.00 will be charged on all checks returned by the bank, plus any

bank fees. After the first returned check, the provider has the option to request cashier's check and/or keep a credit card on file to receive payments. A late fee of \$1.00 per minute may be charged for children picked up after their scheduled pick-up time, that is payable in cash that day. A late fee may be waived if prior notice has been given and arranged. Please ask and do not assume it is okay to be late.

Withdrawal and Refund Policy

For Preschool students, services may be terminated by parent/guardian by giving 2 weeks written notice. For School-Age care, services may be terminated only at the end of any given semester. Therefore for School-Age students, once a student is enrolled, he/she will be expected to continue in both attendance and payment until the end of that semester. Once a new semester begins, the semester-long commitment will begin again. Wild Roots Preschool and Child Care Center has the right to terminate services without notice if the parent does not comply with the policies set forth or if scheduled payments are over two weeks late. If parent/guardian terminates service before the month is over, any part of the tuition that was paid for will not be refunded.

Consent For Photography and Information For Publication

Wild Roots Preschool and Child Care Center will occasionally take photographs of children engaged in activities. Jurisdiction/ Venue/ Attorney's Fees

This contract is to be construed under the laws of the State of California. The parties agree to the jurisdiction and venue of the State of California, County of Riverside. Should action be brought to enforce or interpret the provision of the Contract, the prevailing party shall be entitled to attorney's fees in addition to whatever other relief is granted.

The person(s) executing this Contract on behalf of the child are hereby representing that they have the legal authority to do so.

By signing this document, each party has read and considered the above terms and conditions, and legally promises and agrees to all stated here or attached hereto.

Other Terms

State childcare licensing regulations are on file at the center and are available for review upon request. Certain State childcare licensing regulations have requirements in addition to those contained in this Agreement. Regulations may also be found at www.cclcd.ca.gov

In certain circumstances it may be necessary to discontinue a child's enrollment. This decision is based on the best interest of the child concerned, other children in the class, and the well being of everyone at the school. Every effort will be made to correct the situation before a final decision is made (i.e. moving a child to another class, redirecting behaviors, providing choices, separating children who are not getting along, or other interventions).

Disenrollment may be a result of the following:

- Abuse of other children, staff, or property by child and or parent/guardian
- Continued violation of policies by child or parent/guardian
- Disruptive or dangerous behavior by child or parent/guardian
- The school's inability to meet the child's need or the parent/guardian expectation
- Non-payment of tuition

This is a partial list and we reserve the right to end enrollment of a child at any time for any reason deemed appropriate. Whenever possible, prior notification will be provided to the parent.

Inspection Authority – Section 101200

The California State Department of Social Services (CDSS) or other public agency authorized by CDSS to assume such responsibilities shall the authority to interview children or staff, and to inspect and audit school records without prior consent. The center shall make provisions for private interviews with any child(ren) or staff member; and for the examination of all records relating to the operation of the center. The Department shall also have authority to observe the physical condition of the child(ren), including conditions that could indicate abuse, neglect, or inappropriate placement.
